Service fees of waste management 2019

The fees include VAT 24 %, collection, transportation and waste treatment. The fees cover collection carried out at regular intervals.

If a property has several waste container storage areas, a separate fee is charged for the emptying of the waste containers of each storage area in accordance with the waste management service fees.



Waste management regulations

The city's waste management regulations determine which kinds of waste the properties need to sort and collect separately. The waste management regulations apply within the metropolitan area (Helsinki, Vantaa, Espoo, Kauniainen) and Kirkkonummi.

Usually, the more inhabitants, the more waste types is recommended to collect within the property. See further information on [waste management regulations](#).

Rent a waste container from us

We recommend a rental bin for waste collection. Rental bins are delivered to housing properties free of charge. Broken bins will be replaced without extra cost.

Please note that after the new waste management regulations became effective in March 2019, the bin colour codes for waste types were redefined.

Although some of the bin colours changed, we will not replace an old waste bin until it is broken. You may also use your own waste bins.

The fee for a separate protective sack placed in the waste container is 1.57€ /each installed.

We don't offer new contracts for cardboard collection anymore. You can order a carton collection service for your property which also includes brown cardboard.

Large cardboard boxes can be collected in a rental cage trolley. The rental price for a cage trolley is € 1.29 / a week. The cage trolley can be collected once a week, every second week, every fourth week or every eighth week.

Plastic packaging waste



We collect plastic packaging waste always up to once a week in the beginning, but if it turns out that the property produces more plastic packaging waste, the collection frequency can be increased to twice or three times a week.

Properties with ten or more households can order only a waste container of 660 litres for plastic packages. Smaller containers would fill up too quickly and therefore cause problems for waste management. Smaller properties may choose other container sizes.

We recommend to use a HSY rental waste container for collecting plastic packaging waste. [See rental fees](#) for containers. You can also use your own waste container.

Fees for 140-240 l and 300-360 l containers

Annual fees do not include the rental container. Fee for 140-240 litre container is 0.25€/week and 300-360 litre container rental fee is 0.35€/week.

*A waste container of 140-240 litres is only for detached or semi-detached houses.

**A waste container of 300-360 litres can only be ordered for properties with less than 10 households.

Excess waste

Waste that has been placed outside the container is excess waste. All waste packed in a plastic bag is charged as mixed waste. Excess waste should be placed immediately next to the waste container. All material immediately next to the waste containers is treated as excess waste.

Maximum amount for excess waste is 2 m³ or 15 kg / sack. Order a collection for a bigger amount of excess waste from our [customer service](#). Minimum invoicing amount is 0,1 m³ (100 litres). You can also order a pick-up service for bigger items. Read more about [Sortti pick-up service](#).

Regional collection fee in Kirkkonummi

Our regional waste collection points in Kirkkonummi are located in Porkkala and Långvik. The regional waste collection points and Sortti Stations are available for holiday homes and for around-the-year properties that are inaccessible by garbage trucks.

The use of regional waste collection points and Sortti stations by small properties is subject to an annual fee. Receipt of payment must be presented upon request when dropping off waste to these locations. The service only covers mixed household waste.

Construction waste, furniture and other large waste items can be brought to a Sortti Station. A pick-up service is also available for large waste items.

The fee for regular residents is 94,40 € per year and summer residents 35,53 € per year.

Transferral with a sludge vacuum truck from one sludge well group to another is 35 € / transferral on the same property.

Transferral fee includes a transfer up to 0,5 kilometers.

When placing the order for septic tanks and closed tanks, HSY must be informed

- if the suction truck cannot get any closer to the tank than 40 metres
- if there will be other operations taking place at the same time which will hinder the tank emptying procedure, e.g. earth removal. The charge for extra work is € 80.00/hr. The minimum charge is per 0.5 hr
- if there is significant altitude between the suction truck and the septic tank.

Emptying of sludge loads over 14 m³ must be agreed upon separately.

Transferral with a sludge vacuum truck from one sludge well group to another is 35 €. The charge for extra work is 80 €/ hour.

Sortti pick-up service

Order the Sortti pick-up service to pick up your bigger waste items. The service is meant for bigger items that do not fit in the normal container and cannot be transported in the regular waste transportation, e.g. old fridge, freezer, oven, sofa or other household fixture. The price of the pick-up is 60-120 €. One pick-up covers maximum nine items. The size and amount of the parts determine how many items are included in one pick-up.

Bring **company-generated hazardous waste**, fluorescent tubes and energy-saving bulbs to Kivikko Hazardous Waste Reception Station. We charge for the reception of hazardous waste according to this pricelist.

Sortti Stations do not accept:

- car tyres > see places [Rengaskierrätys](#)
- medicines, needles or syringes > take these to pharmacy
- fireworks, emergency signal rockets, explosives, bullets, guns > take these to the police
- kitchen biowaste
- NB: you cannot bring waste to Sortti Stations by a lorry.

Waste liable to charge

We charge for **single objects** such as an armchair, a divan bed or couch according to the volume space.

Waste treatment fees

Weighed waste loads

Waste loads transported by truck or other large vehicle are accepted at the Ämmässuo Waste Treatment Centre in Espoo.

- The customer (the producer and the holder of the waste) must be aware of the quality, characteristics and origin of the waste in his/her possession as well as its suitability for landfill use, and be able to provide this information upon delivery. A Waste Transportation Document is required for certain types of waste in accordance with current legislation.
- The treatment fee is determined by the weight of the waste load, the type of waste and the quality of waste. The load is assessed at the reception. If a load includes several different types of waste, the fee is determined based on the most expensive type of waste. Fees for contaminated waste are determined based on agreement.
- HSY will charge the customer for any additional costs incurred from waste being directed to incorrect treatment as a result of missing or inadequately filled documentation, such as a missing Waste Transportation Document or incorrect waste type declaration.

Fixed-term collection and interruptions

You may arrange to have the waste bin or bins of your summer home, for example, emptied only during a specific period of time. During the summer holiday season (weeks 18 to 40), the waste bins of holiday homes that are only used in summer time must be emptied at the interval referred to in the waste management regulations.

If a property is unused for at least one week, waste collection can be interrupted for a specified period of time. A notification must be submitted to HSY no later than one week before the planned start of the interruption. If the interruption is longer than a year or there are more than two consequent interruptions, an application for an exception to waste management regulations must be submitted.
